Terms and Conditions

1. Service rates are quoted excluding GST. GST is charged at a rate of 10% where applicable.
2. Where staff are required to transport clients in the staff's vehicle or perform tasks whilst client is not accompanying (eg. Shopping), travel will be charged at \$0.80 per kilometre.
3. Cancellations: In accordance with the NDIS price guide short notice cancellations can be charged at 100% of the agreed fee associated with the activity from the participants plan. The price guide defines a short notice cancellation as:
 - The participant does not show up for a scheduled support within a reasonable time, or is not present at the agreed place and within a reasonable time when the provider is travelling to deliver the support; or
 - The participant has given less than two (2) clear business days' notice for a support that meets both of the following conditions:
 - the support is less than 8 hours continuous duration; AND
 - the agreed total price for the support is less than \$1000; or
 - has given less than five (5) clear business days' notice for any other support.
4. Mercy Health may vary fees in accordance with NDIS price guide set by the NDIA.
5. Gazetted public holidays may be substituted for another day under state or territory law.
