## Terms and Conditions

2. Cancellations: In accordance with Award conditions that apply to our staff, notification of cancelled services must be made by 5pm of the weekday prior to the planned service. Mercy Health reserves the right to charge all or part of a planned service fee if the service is cancelled after 5pm the prior weekday.
3. Mercy Health may vary fees annually and will provide 4 weeks' notice of fee increases in writing for increases up to a maximum of 5.5%. Should the costs of providing service increase significantly as a result of circumstances out of Mercy Health's direct control (for example, employee Award terms and conditions), Mercy Health reserves the right to make an out of cycle fee adjustment with a minimum 4 weeks' notice provided in writing so long as the increase does not exceed 5.5%. Any increases above 5.5% will be agreed via consultation.
