Care Management*

Care management is an important service that includes coordinating care and services that will help you deliver on the goals you identified in your Care Plan. Every Home Care Package, including those being self-managed will require some level of care management.

Approach to care management	<p><i>We have two options to assist you in choosing your level of Care Management.</i></p> <ol style="list-style-type: none"> <i>1. Full Support is based on a relationship approach. This provides you with full access to your own Care Advisor and a Service Coordinator who will support you with your health and wellbeing goals and ensure your services are organised and integrated to meet your needs. Full support includes a fixed care management fee, regardless of how much care coordination and care advisory you need.</i> <i>2. Self-support ensures that your services are based on what is important to you and provides you with the opportunity to participate in directing your care and services. We will encourage you to take an active role in planning, reviewing and arranging your care and support. If your circumstances change, our Care Management team can assist you to change your care and services to meet your individual needs. A fee for service applies.</i>
